#### APPROVAL OF FIDELITY BOND

- b. which is a "bank" (as defined in Section 2(a) of the Investment Company Act of 1940).

This Bond does not afford coverage in favor of the employers of persons as set forth in e. - (3) a Telex, TWX, or similar means of communication,
